# RULES OF THE LONDON COCKER SPANIEL SOCIETY

Amended in 2017

## 1. The name of the Society to be THE LONDON COCKER SPANIEL SOCIETY

The object of the society is for the benefit of its members and will not be classed as a trading business, so that all profits from any source, functions and/or activities of the society shall be maintained for the benefit of and further education of its members in the training, showing, breeding pertaining to Cocker Spaniels.

## 2. The Society shall consist of

a) A Patron, President and Vice-President, appointed by the Committee on the bases of long association or service to the breed or the society, but who will not be members of the Committee nor have voting rights when attending Committee meetings. These positions to be reviewed annually.

b) A Chairman, Vice-Chairman, Hon. Gen. Secretary, Hon. Treasurer, shall be ex officio members of the committee and who shall have voting rights. The Chairman, Hon. Gen. Secretary, and Hon Treasurer shall stand for three year term but retire individually in rotation over 3 years and be eligible for re-election. The Vice Chairman shall be appointed by the Committee at the first meeting following the AGM.

c) The Committee of not more than twelve members four of whom shall retire annually but be eligible for re-election. Five shall form a quorum at Committee meetings, this number to exclude officers. The Committee shall appoint from its number a Memberships Administrator and a Show Secretary.

d) An unlimited number of members whose names and addresses shall be recorded by the Society, and a list of members and their addresses will be available for inspection if so requested by members or by The Kennel Club Limited..



3. Applications for membership shall be subject to approval by the committee. Members shall pay an annual subscription which shall be of such amount as shall be recommended from time to time by the Committee, agreed in General Meeting, and notified to the Kennel Club. All subscriptions are renewable on 1st January each year. No member whose subscription is not fully paid up is entitled to any privileges of membership.

Members agree to abide by the Rules of the London Cocker Spaniel Society, The Kennel Club Code of Ethics and the Cocker Spaniel Breed Council Guidelines.

4. The management of the society and its property shall be vested in the Committee

The Committee shall also have powers;

- a. To co-opt members onto the Committee in the event of positions becoming vacant between Annual General Meetings.
- b. The Committee may confer life membership on members who have given long, loyal and distinguished service to the Society.
- c. To make by-laws.
- d. To decide upon any matters not provided for by these rules.

But The Kennel Club shall be the final authority for interpreting the Rules of the society in all matters relating to canine or Society matters.

5. Annual General Meeting and Election of Officers and Committee.

a. The election of Officers and Committee shall be by postal ballot in accordance with Rule 7 hereunder. One Officer shall retire annually after serving a three year term together with four members of the Committee longest in office, all of whom shall automatically stand for re-election and shall have their names entered on the Society's voting papers for re-election unless they have given notice in writing to the Society that they do not wish to stand for re-election.

b. Nominations for the election of Officers and Committee, duly proposed and seconded and with the signed consent of the nominee, shall be made in writing and shall be sent by post to the Honorary General Secretary to arrive on or before a date to be specified in the invitation to submit nominations which will be circulated to all home members and publicised in the dog press. The result of the postal ballot for Officers and Committee shall be announced at the Society Annual General Meeting.

c. Those eligible to vote must have been fully paid up members of the Society for the proceeding and the current financial year in which the AGM is held. Those eligible to nominate or to be nominated as Officers or Committee members must be fully paid up members for two years proceeding and the current financial year in which the AGM is held.

d. Any items for inclusion on the Agenda at the AGM shall be made in writing and sent by post to the Honorary General Secretary to arrive by a date to be specified in order that such items shall be included in the Notice of Meeting as set out in 5(e)

e. The committee will decide the time and place of the AGM and give at least twenty-one day's notice of the meeting by publishing the information in Our Dogs paper and on the LCSS website. Members may request an emailed or postal copy of Agenda and Certified Accounts (when they are available). The certified accounts will be available on request to members fourteen days prior to the AGM. Ten members, excluding Officers shall form a quorum.

f. No business shall be transacted at an Annual General Meeting unless notice thereof appears on the Agenda with the exception of that which in the opinion of the chairman of the meeting is urgent.

6. A Special General Meeting may be called by the committee at any time upon twenty one (21) day's notice being given in writing; or a requisition duly signed by at least twenty-five members may be submitted to the Hon. Gen. Secretary. Subsequent upon the requisition and names of requisitioners being made available to the Committee, the Committee will call and conduct a Special General Meeting. The Committee will invite an independent person to chair the meeting subject to majority approval by those members present at the meeting and entitled to vote. No less than 25 members to form a quorum at any Special General Meeting. The Requisition and the names of the signatories must be available at the meeting.

The notice must contain all the relevant information concerning the said Special General Meeting and business to be conducted, and no business other than that named in the notice shall be brought before a Special General Meeting.

7. Voting.

a. Those eligible to vote at any General Meeting of the Society must have been fully paid-up members of the Society for the proceeding year and the current financial year in which the meeting is held. Voting at all the Society's meetings shall be by show of hands or at the discretion of the Chairman and shall be carried by simple majority. The voting for officers and or committee members shall be by postal ballot to all home members. Voting papers shall be forwarded to either The Kennel Club or to a nominated firm of accountants or a professional person approved by the Committee and who is not a member of The London Cocker Spaniel Society. In the event that nominations do not exceed the vacancies no ballot papers will be circulated.

b. In all matters, the Chairman shall have a casting vote (which may be cast notwithstanding that the time for voting may have ended under clause 5(b) above) and his or her ruling upon any point shall be binding at all times.

C. Each member shall be entitled to one vote but for the avoidance of doubt in the case of a partnership of not more than two persons, each of those persons shall have one vote.

8. Any member of the Committee being absent at three consecutive Committee meetings shall have his or her attention drawn to the fact and unless a reasonable excuse is forthcoming such member's seat on the Committee shall become vacant.

9. A Banking account shall be opened in the name of the Society into which all revenue of the Society shall be paid and from which withdrawals shall only be made on the signature of two of the following: the Honorary Treasurer, the Honorary General Secretary and the Chairman.

10. Any member who shall be disqualified under The Kennel Club Rule A11j (5) and/or under Kennel Club Rule A11j (9) shall ipso facto cease to be a member of the society.

If the conduct of any member shall, in the opinion of the Committee of the Society, be injurious or likely to be injurious to the character or interests of the Society, the Committee of the Society may, at a meeting the notice convening which includes as an object the consideration of the conduct of the member, determine that a Special General Meeting of the Society shall be called for purpose of passing a resolution to expel

him/her. Notice of the Special General Meeting shall be sent to the accused member, giving particulars of the complaint and advising the place, date and hour of the meeting that he/she may attend and offer an explanation. If at the meeting a resolution to expel is passed by a two-thirds majority of the members present and voting, his/her name shall forthwith be erased from the list of members and he/she shall thereupon cease for all purposes to be a member of the Society, except that he/she may, within two calendar months from the date of such Meeting appeal to the Kennel Club upon and subject to such conditions as The Kennel Club may impose.

If the Society expels any member for discreditable conduct in connection with dogs, at our show the Society must report the matter in writing to the Kennel Club within seven days and supply any particulars required.

11. The financial year of the Society shall be from 1st January to 31st December. The accounts will be certified annually by a person approved by the committee and presented to the members at the Annual General Meeting. Certification of the accounts must be carried out by one qualified accountant or two unqualified individuals with accountancy experience. Any one certifying accounts should be unconnected with the Committee. At the discretion of the AGM, Honoraria may be paid in respect of services to the Society during the previous financial year.

12. The property of the Society shall be vested in the Committee, and in the event of the Society ceasing to exist a Special General Meeting shall be called to decide the disposal of any assets. A final statement of audited accounts with a record of the disposal of the property of the Society shall be forwarded to the Kennel Club within six months, and the persons named as Officers and Committee of the Society on the last return furnished to The Kennel Club will be held responsible by the Kennel Club for the proper winding up of the Society. All cups, trophies and awards that have been donated to the Society shall be deemed to be the sole property of the Society and it is only under this condition that they will be accepted. The officers and Committee shall make every effort to ensure that the wishes of the donors are respected.

13. The rules of the Society shall not be altered except at the Annual General Meeting or Special General Meeting notice of which includes details of the proposal to alter the Rules. Such alterations shall not be brought into force until The Kennel Club has been advised and has

given its approval to the alterations.

14. The Society shall not join any Federation of Societies or Clubs.

15. The Officers acknowledge that during the month of January each year maintenance of title fee will be forwarded to The Kennel Club by the Honorary General Secretary for continuance of registration and that by the 31st July in each year other returns as stipulated in The Kennel Club regulations for the Registration and Maintenance of Title of Societies and Breed Councils and the affiliation of Agricultural and Municipal Authorities, will be forwarded to the Kennel Club.

The Officers acknowledge their duty to inform The Kennel Club of any change of Secretary to the Society which may occur during the course of the year

16. No person whilst an un-discharged bankrupt may serve on the Committee of or hold any other office or appointment within a Kennel Club Registered Society.

1. Sheridan's LUJESA LIVING THE DREAM. Substantial black dog, lovely head and expression, tight dark eye, good depth of chest and good spring of rib, elbows well tucked in, thickly padded feet, well boned, well angulated, good width of stifle, moved well with drive.

### SPECIAL NOVICE (3,1)

1. Sheridan's LUJESA LIVING THE DREAM. Substantial black dog, lovely head and expression, tight dark eye, good depth of chest and good spring of rib, elbows well tucked in, thickly padded feet, well boned, well angulated, good width of stifle, moved well keeping a level topline.

2. Corcoran's TROVEROTHWAY VANITY FAIR. Pretty B&T bitch, ample neck, well angulated hindquarters, short in loin, would just prefer a touch more width all through, moved OK.

### SPECIAL POST GRADUATE (5,2)

1. Shapland's DERACOR DREAM TIME. Gorgeous black bitch, so balanced and compact. Not a big girl but has everything in correct proportions. Beautiful gentle expression, square muzzle and dark eye. Good reach of neck and lay of shoulder, well ribbed, short in loin, deep chest and good return of upper arm, good bend of stifle, moved with ease and confidence around the ring. Looking forward to watching her progress. BIS.

2. Rofe's OAKROSA RAIDEN. Well boned black dog, unlucky to meet 1. Top quality dog with lots to like. Neat thickly padded feet, masculine head, tight dark eye, good spring of rib, happy and relaxed on the move.

1. Edgington's UXENDEL SEA VENTURE. 10 mth blue dog full of exuberance and a great personality. It was such a delight to see his merry disposition which is sadly lacking in some exhibits. Pleasing outline, masculine head, square muzzle, well angulated front and hindquarters which he used to drive around the ring keeping a

level topline on the move which was not always easy to appreciate when standing due to his exuberant nature. He has time on his side to settle and should be given the opportunity to enjoy himself. BPIS.

#### SPECIAL NOVICE (6)

1. Parker's ANNILANN MISS SWEATHEART AT WEYHILL. I have watched this puppy from the ringside and was not disappointed on handling her. She has been slower to mature than some but just keeps on getting better. Lovely feminine head and gentle expression, good reach of neck and lay of shoulder, neat thickly padded feet, good width and depth of chest, hocks well let down, well presented and has a lovely nature, moved well.

2. Braddock's RIONDEL AURORA AT CARINOSA. This blue bitch is still a minor puppy and just needs time. She has a lovely head and gentle expression, square muzzle, correct straight front and neat thickly padded feet, she is short coupled and moved well once settled.

3. Harrison, Thorpe & Harrison's HARBETHOL LOOK MAN OF MAGIC FOR ARCHBY.

#### POST GRADUATE (7,4)

1. Wildman's REEMIFF MIDNIGHT BLUE FOR CHANMALO SHCM. Lovely substantial dog in good coat and condition. Masculine head, tight dark eye, good width and depth of chest, good reach of neck and well-placed shoulders, good spring of rib, well angulated and moved well. Well presented.

2. Parker's UXENDEL SPOTSEA AT GAVINEAL. This little bitch obviously loves her handler, but I have written in my notes that her handler needs to try and relax a little bit. Short cobby bitch with a correct straight front. Moved well.

### SPECIAL OPEN (1)

1. Bavin & Austin's ROJOYS CHASE THE DREAM JW SHCM. Lovely blue bitch I liked a lot. Correct straight front, neat thickly padded feet, feminine head, short in loin, deep body, well angulated hindquarters and good width from behind. Would just prefer a better lay of shoulder to balance the picture. Moved well but needs to slow down so her movement can be appreciated. Immaculate presentation.

### ANY COLOUR

#### VETERAN (8,7)

1. Wildman's MYSTICAL MILOW AT CHANMALO SHCM VW. 9-year-old blue dog in fabulous coat and condition, he has lovely clean teeth too and it is easy to appreciate the work that his owner puts into his upkeep. Masculine head with well defined stop, good reach of neck and good shoulder placement, well boned, good return of upper arm and well angulated hindquarters, short below hocks, level topline, moved like a youngster. A real credit to his owner. BV.

#### MINOR PUPPY (2)

1. Burnet's CHARMWEN WHITE KNIGHT. Lovely B&W puppy with lots to like. Well angulated, short cobby body, good head, square muzzle, well ribbed, deep chest, neat thickly padded feet, short below hocks, very promising puppy and has time on his side to settle but his movement was difficult to assess at times. BMPIS.

2. Braddock's RIONDEL AURORA AT CARINOSA. As previous.

1. Harrison, Thorpe & Harrison's HARBETHOL LOOK MAN OF MAGIC FOR ARCHBY. This blue dog was much more settled in this class. He has a lovely masculine head, gentle expression, square muzzle, well defined stop, well boned, neat thickly padded feet, would prefer a shorter loin but he is a lovely dog with lots to like. Correct tail set and moved well in this class.

## TYRO (2)

1. Bindza's CACHEL HEARTTHROB AT LAURELLAKES. I really liked this blue dog; he is so balanced from any angle. Short, cobby, good spring of rib, good reach of neck and correct lay of shoulder, lovely head and expression, correct straight front, well angulated hindquarters, short below hocks, correct tail set, moved with drive Should do well at all levels. RBIS.

2. Roles' TENDERFIELD SONG FOR BARNEY. Excitable liver roan dog, some good attributes but just far too long in loin which spoils his outline. Well boned, correct eye colour and well presented.

## GRADUATE (2)

1. Shapland's DERACOR DREAM TIME. As previous.

2. White's MERRYSPRINGS MAGIC STAR. Lovely blue dog unlucky to meet 1 and giving his handler a hard time today. Well sprung ribs masculine head with well defined stop, good reach of neck and lay of shoulder. Short below hocks, good tail set. Would just prefer a shorter loin to balance the picture.

## SPECIAL BEGINNERS (6,5)

1. Lockwood's ZAKOVA FIRE DANCER. Well boned gold bitch with a lovely sweet temperament, well angulated hindquarters and good spring of rib. Unfortunately, she was very wet from the rain, however this didn't deter her from moving around the ring as if she owned it!



### OPEN DOG (2,1)

1. Cassidy's MANCHELA HUGO BOSS JW SHCM. Well grown blue dog of excellent type, correct straight front, neat thickly padded feet, masculine head, well angulated and short below hocks, would just prefer a bit more width all through, very well presented.

### OPEN BITCH (5,3)

1. Morgan's WILMERELLA FIRE AND ICE TO TOPKYRI. Headed a class of two very different types. Slightly longer cast than 2 but scored on her gorgeous head and melting expression and level topline which she held on the move. Neat thickly padded feet, good depth of chest, lovely dark eye. Good return of upper arm and well angulated hindquarters. Moved with drive.

# THE BREED STANDARD

A Breed Standard is the guideline which describes the ideal characteristics, temperament and appearance of a breed and ensures that the breed is fit for function. Absolute soundness is essential. Breeders and judges should at all times be careful to avoid obvious conditions or exaggerations which would be detrimental in any way to the health, welfare or soundness of this breed. From time to time certain conditions or exaggerations may be considered to have the potential to affect dogs in some breeds adversely, and judges and breeders are requested to refer to the Kennel Club website for details of any such current issues ([www.the-kennel-club.org.uk/services/public/breeds/watch](http://www.the-kennel-club.org.uk/services/public/breeds/watch)) If a feature or quality is desirable it should be present in the right measure. However if a dog possesses a feature, characteristic or colour described as undesirable or highly undesirable it is strongly recommended that it should not be rewarded in the show ring.

## **General Appearance**

Merry, sturdy, sporting; well balanced; compact; measuring approximately same from withers to ground as from withers to root of tail.

## **Characteristics**

Merry nature with ever-wagging tail shows a typical bustling movement, particularly when following scent, fearless of heavy cover.

## **Temperament**

Gentle and affectionate, yet full of life and exuberance.

## **Head and Skull**

Square muzzle, with distinct stop set midway between tip of nose and occiput. Skull well developed, cleanly chiselled, neither too fine nor too coarse. Cheek bones not prominent. Nose sufficiently wide for acute scenting power.

## **Eyes**

Full, but not prominent. Dark brown or brown, never light, but in the case of liver, liver roan and liver and white, dark hazel to harmonise with coat; with expression of intelligence and gentleness but wide awake, bright and merry; rims tight.

## **Ears**

Lobular, set low on a level with eyes. Fine leathers extending to nose tip. Well clothed with long, straight silky hair.

## **Mouth**

Jaws strong with a perfect, regular and complete scissor bite, i.e. upper teeth closely overlapping lower teeth and set square to the jaws.

## **Neck**

Moderate in length, muscular. Set neatly into fine sloping shoulders. Clean throat.

## **Forequarters**

Shoulders sloping and fine. Legs well boned, straight, sufficiently short for concentrated power. Not too short to interfere with tremendous exertions expected from this grand, sporting dog.

## **Body**

Strong, compact. Chest well developed and brisket deep; neither too wide nor too narrow in front. Ribs well sprung. Loin short, wide with firm, level topline gently sloping downwards to tail from end of loin to set on of tail.

## **Hindquarters**

Wide, well rounded, very muscular. Legs well boned, good bend of stifle, short below hock allowing for plenty of drive.

### **Feet**

Firm, thickly padded, cat-like.

### **Tail**

Set on slightly lower than line of back. Must be merry in action and carried level, never cocked up. Previously customarily docked.

Docked: Never too short to hide, nor too long to interfere with, the incessant merry action when working.

Undocked: Slightly curved, of moderate length, proportionate to size of body giving an overall balanced appearance; ideally not reaching below the hock. Strong at the root and tapering to a fine tip; well feathered in keeping with the coat. Lively in action, carried on a plane not higher than level of back and never so low as to indicate timidity.

### **Gait/Movement**

True through action with great drive covering ground well.

### **Coat**

Flat, silky in texture, never wiry or wavy, not too profuse and never curly. Well feathered forelegs, body and hindlegs above hocks.

### **Colour**

#### **Solid Colours**

Black; red; golden; liver (chocolate); black and tan; liver and tan; No white allowed except a small amount on chest.

#### **Particolours Bicolours**

Black and white; orange and white; liver & white; lemon and white; All with or without ticking

#### **Tricolours**

Black, white and tan; liver, white and tan.

#### **Roans**

Blue roan; orange roan; lemon roan; liver roan; blue roan and tan; liver roan and tan.

Any colour or marking other than the above is undesirable.

### **Size**

Height approximately: dogs: 39-41 cms (15 1/2-16 ins); bitches: 38-39 cms (15-15 1/2 ins).

Weight approximately: 13-14.5 kgs (28-32 lbs).

### **Faults**

Any departure from the foregoing points should be considered a fault and the seriousness with which the fault should be regarded should be in exact proportion to its degree and its effect upon the health and welfare of the dog, and on the dog's ability to perform its traditional work.

### **Note**

Male animals should have two apparently normal testicles fully descended into the scrotum.

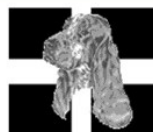

# KENNEL CLUB CODE OF ETHICS

All breeders who register their puppies, and new owners who register ownership of their dogs with the Kennel Club, accept the jurisdiction of the Kennel Club and undertake to abide by its general Code of Ethics.

Breeders/Owners:

1. Will properly house, feed, water and exercise all dogs under their care and arrange for appropriate veterinary attention if and when required.
2. Will agree without reservation that any veterinary surgeon performing an operation on any of their dogs which alters the natural conformation of the animal, or who carries out a caesarean section on a bitch, may report such operation to the Kennel Club.
3. Will agree that no healthy puppy will be culled. Puppies which may not conform to the Breed Standard should be placed in suitable homes.
4. Will abide by all aspects of the Animal Welfare Act.
5. Will not create demand for, nor supply, puppies that have been docked illegally.
6. Will agree not to breed from a dog or bitch which could be in any way harmful to the dog or to the breed.
7. Will not allow any of their dogs to roam at large or to cause a nuisance to neighbours or those carrying out official duties.
8. Will ensure that their dogs wear properly tagged collars and will be kept leashed or under effective control when away from home.
9. Will clean up after their dogs in public places or anywhere their dogs are being exhibited.
10. Will only sell dogs where there is a reasonable expectation of a happy and healthy life and will help with the re-homing of a dog if the initial circumstances change.
11. Will supply written details of all dietary requirements and give guidance concerning responsible ownership when placing dogs in a new home.
12. Will ensure that all relevant Kennel Club documents are provided to the new owner when selling or transferring a dog, and will agree, in writing, to forward any relevant documents at the earliest opportunity, if not immediately available.



# KENNEL CLUB CODE OF ETHICS

13. Will not sell any dog to commercial dog wholesalers, retail pet dealers or directly or indirectly allow dogs to be given as a prize or donation in a competition of any kind. Will not sell by sale or auction Kennel Club registration certificates as stand alone items (not accompanying a dog).

14. Will not knowingly misrepresent the characteristics of the breed nor falsely advertise dogs nor mislead any person regarding the health or quality of a dog.

15. Members will, when breeding dogs, adopt as a minimum standard the principles, requirements and recommendations as embodied in the Kennel Club's Assured Breeder Scheme. It is strongly recommended that members who breed should apply to join the scheme.

BREACH OF THESE PROVISIONS MAY RESULT IN EXPULSION FROM CLUB MEMBERSHIP, AND/OR DISCIPLINARY ACTION BY THE KENNEL CLUB AND/OR REPORTING TO THE RELEVANT AUTHORITIES FOR LEGAL ACTION, AS APPROPRIATE

### C LIST

For aspirant judges who have shown an interest in the breed and have the support of The Cocker Spaniel Breed Council. Up to 6 classes provided that a puppy class is scheduled

### A3 LIST

Applicants should note that when considering an application for inclusion on The Breed Council B and A Lists no more than 6 classes will be accepted for a single appointment, and if so judged the number of dogs reduced pro-rata i.e. 8 classes, 32 dogs judged will be reduced to 6 classes 24 dogs judged. UNLESS the applicant is at the time of acceptance of the appointment included on the B List of either The Cocker Spaniel Breed Council or of The Cocker Spaniel Club.

NB: Requirement for all First time CC appointment applications received at the Kennel Club after

1st January 2011. Each applicant must have attended an OPEN COCKER SPANIEL STAKES.

Attendees must arrange in advance with the relevant Field Trial Secretary that they can attend and observe (not all Secretaries or Landowners will want member of the public at their events). Attendees must stay for the day and obtain a marked card (catalogue in our terms) signed by the Field Trial Secretary. The marked card is to be sent to the Kennel Club with the completed application. It is strongly suggested that a copy of the card is taken and retained. Some trials will allow attendees to stand with the judge(s) and some will not; it is not essential. Observation of a Cocker working is the object of the exercise.

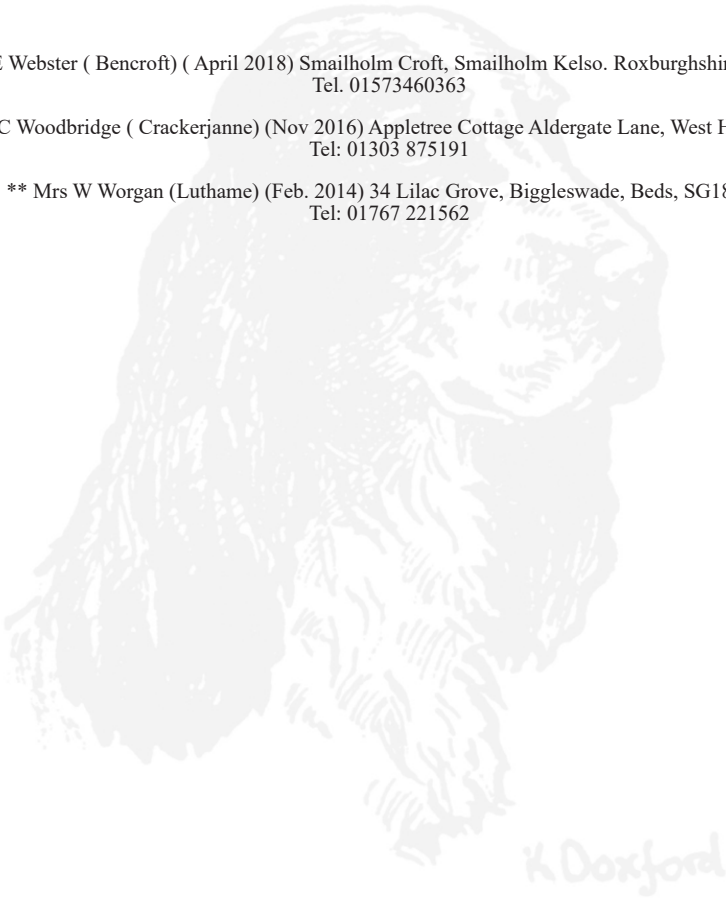

I first met Geoffrey in the 1970's when he used to bring his mother's dogs to my shop for grooming. She had Griffons and Chihuahuas who needed regular trimming and grooming, but despite their inclination to bite, Geoffrey would not allow them to be muzzled during the process and so had to stay to hold them and often left with scars to prove it.

Geoffrey lived in Woking with his mother, but every weekend he drove her down to their seaside bungalow that had a big picture window where she could sit watch the world go by here in Selsey.

Over the years we became good friends, and his enthusiasm for the canine world broadened into accompanying me to the various dog shows I attended with my own cocker spaniels. He thoroughly enjoyed the showing scene and soon became a regular visitor to many of them, frequently stepping in to help steward in the rings.

During the week days Geoff worked for Woking Council and became their champion of amongst many things, the Electoral Register organising the Voting stations, and laboriously going through postcodes and names to seek out possible fraudsters. His weekday evenings were spent at the Woking Theatre complex, walking the floor, monitoring the 'doors' and keeping troublemakers at bay, but he always found time to chat to the customers and the stars. He was always the person to 'go to' if problems occurred and this became his regular evening job.

As Lily's godfather, Geoffrey undertook his role with joy and devotion, assisting at weekends and holidays to care for and entertain her in her early years.

With Lily came the ponies, the horse shows and the Side Saddle events, all of which would not have been possible without Geoffrey's enthusiasm and financial sponsorship. Early August each year Geoff and team Edgington attended the long weekend of the National Side Saddle Championship Show where we would set up camp and Geoffrey would invite and entertain allcomers under our awning. Their combined effort was rewarded with Lily twice winning the Junior Championship. Geoffrey in particular always enjoyed the side saddle show jumping competitions, and became one of their regular sponsors for these classes, cheering on the Area 8 team for which he was not only their treasurer and rosette keeper but the loudest spectator.

When Lily went off to university Geoffrey continued his devotion as godfather and supported her education right through from Aberystwyth in Wales, to Budapest in Hungary and fortunately he was aware that she very recently qualified as a vet.

In the meantime, following retirement from Woking Council Geoff maintained his interest in my dogs and the showing world and remained an active Committee member of the London Cocker Spaniel Society, he was always ready with a kind word and a helping hand and eventually became the vice chairman of the society and attended Crufts as a member of the team helping to man the stall for many years. Things will not be the same without him.

His loss was sudden and unexpected and a shock to all who knew him. He will be greatly missed.

Over the years we became good friends, and his enthusiasm for the canine world broadened into accompanying me to the various dog shows I attended with my own cocker spaniels. He thoroughly enjoyed the showing scene and soon became a regular visitor to many of them, frequently stepping in to help steward in the rings.

During the weekdays Geoff worked for Woking Council and became their champion of amongst many things, the Electoral Register organising the Voting stations, and laboriously going through postcodes and names to seek out possible fraudsters. His weekend evenings were spent at the Woking Theatre complex, walking the floor, monitoring the 'doors' and keeping trouble-makers at bay, but he always found time to chat to the customers and the stars. He was always the person to 'go to' if problems occurred and this became his regular evening job.

As Lily's godfather, Geoffrey undertook his role with joy and devotion, assisting at weekends and holidays to care for and entertain her in her early years. With Lily came the ponies, the horse shows and the Side Saddle events, all of which would not have been possible without Geoffrey's enthusiasm and financial sponsorship. Early August each year Geoff and team Edgington attended the long weekend of the National Side Saddle Championship Show where we would set up camp and Geoffrey would invite and entertain all-comers under our awning. Their combined effort was rewarded with Lily twice winning the Junior Championship. Geoffrey in particular always enjoyed the side saddle show jumping competitions, and became one of their regular sponsors for these classes, cheering on the Area 8 team for which he was not only their treasurer and rosette keeper but the loudest spectator.

## PET PASSPORTS

Pet passports have all changed since the UK have come out of the European Union. Your existing passport is not valid anymore.

### **WILL I BE ABLE TO TAKE MY PET TO THE EU**

You will be able to take your pet **from England, Scotland and Wales** to the EU, but you will need to follow a different procedure.

The EU has agreed that Great Britain should be given “part two listed” status, allowing pets to travel within its borders providing the owners obtain an Animal Health Certificate (AHC).

This decision is separate to the wider deal between the EU and the UK on trade and their future relationship, announced on 24 December 2020.

The AHC confirms that your pet is microchipped and vaccinated against rabies.

You will need to get a new certificate each time you travel with your pet and you must obtain it within 10 days of the date you travel. The document is valid for four months, for a single trip into the EU, onward travel within the EU and for re-entry to Great Britain.

The certificate will be issued by your vet and this process will begin on 22 December 2020.

On arrival to the EU, you will need to enter through a designated travellers’ point of entry, listed on the EU website.

### **WHAT ABOUT NORTHERN IRELAND?**

If you want to take your pet from England, Scotland or Wales to Northern Ireland, you will have to obtain an AHC, as if you were going on holiday to the EU.

The certificate will have to be presented to a designated travellers’ point of entry in order to undergo the necessary compliance checks.

In addition, for entry from Great Britain into Northern Ireland (as well as into Ireland, Finland and Malta), pet dogs will have to be treated against a type of tapeworm (*Echinococcus multilocularis*), one to five days before

arrival.

The government website says: “The UK government recognises that pet owners and assistance dog users will need time to adjust to these changes. It’s working with the Department of Agriculture, Environment and Rural Affairs (DAERA) on an enforcement approach that takes these challenges into account.”

**The rules apply to guide dogs as well.**

### UK CITIZENS LIVING IN THE EU

If you live in the EU and have a pet passport issued by an EU member state, you will be able to use it to bring your pet to the UK after 2020.

You will be able to return to the EU with the **EU-issued** pet passport as well.

If you are using a **UK-issued** pet passport, the government’s website says you should speak to your vet who will help you to ensure you are compliant with the rules.

## BISCUITS FOR HEALTHY TEETH

150g whole wheat flour

150g wheat bread flour

100g porridge oats

60g shortening (pork lard)

2 tablespoons of rapeseed oil

3 tablespoons of skimmed powdered milk

200ml unsalted chicken stock

Flour for dusting and shelled sunflower seeds to coat.

### Method

Mix the flour, porridge oats, shortening, rapeseed oil and powdered milk thoroughly. Add the chicken stock and knead all the above to make an easy to shape dough. If necessary, add a little water.

Preheat the oven to 400F (200C).

Scoop out one tablespoon of dough at a time and shape a thick roll on a floured surface. Coat with the sunflower seeds.

Cover a baking tray with parchment and place the biscuits on it. Bake in the hot oven for 40-50 minutes. Turn off the heat and allow the dog biscuits to harden for a few hours in the oven.



## DOG RECIPES

### HOMEMADE TREATS FOR YOUR DOG

#### FISH A LA FIFI

7ozs (200g) frozen fish fillet

7ozs (200g) short grain rice

1 hard-boiled egg

2 tomatoes, diced

1tablespoon olive oil

A few leaves of basil

#### Method

Defrost the fish fillet. Cook the rice with two cups of water until almost mushy. Remove from the stove.

Hard-boil and peel the egg, then chop finely.

Fry the fish in olive oil on both sides. Add the tomatoes and fry for another five minutes. Remove from the heat and break up the fish with a fork. Stir in the rice and the chopped egg. Cut the basil leaves into small strips and sprinkle over the food before feeding. Feed in portions to your dogs appetite.

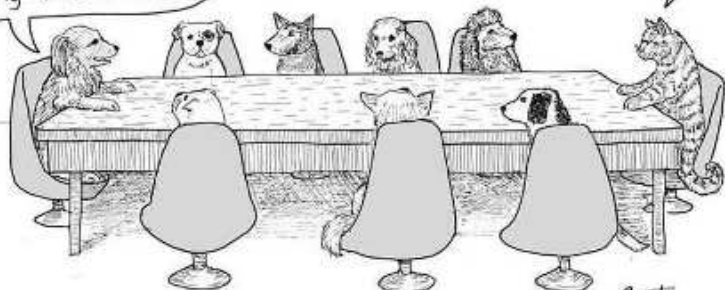

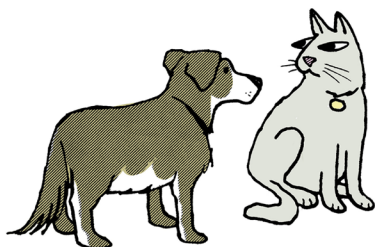

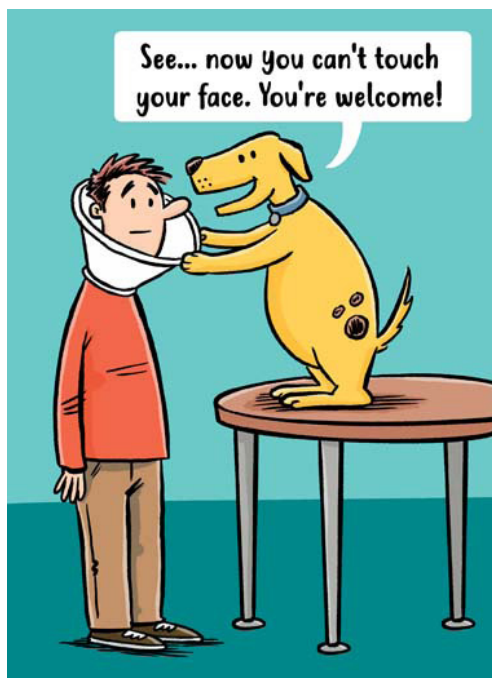
